

she serves on Administrative Senate. She also serves on the AAUW's national Equity and Inclusion Committee and as the current program vice president for the AAUW Ohio. Marlene earned a PhD in the Department of

English at Ohio University, an MA at Michigan State University, and a BA at Barry University. Her primary research and publication areas are diversity in higher education, women's literature, critical theory, and African and diasporic literatures.

She has received national and university fellowships and published Spanish language poetry

as well as numerous articles on Sefi Atta, Laila Lalami, Yvonne Vera, Chimamanda Ngozi Adichie, Chin Ce, and Zee Edgell, among others. Originally from Guatemala, Marlene has lived and conducted research in Belize,

AAUW has announced its new 2020 gender policy agenda outlining AAUW's priority issues for the 2020 election season. The agenda offers us a guide. About those EdChoice Vouchers

The Ohio legislature has been roiling recently with the EdChoice voucher dilemma. The largest of Ohio's five voucher programs, it was originally intended to provide an escape from failing schools for students from low-income and middleincome families. But, changes to the state's report card system appeared to drastically expand the program into school districts not considered to be failing. A low letter grade for even one component in an individual building could affect a district's standing, so that many districts considered to be of high quality could be considered failing. The number of failing school districts would have grown from 139 in the fall of 2019 and 40 in 2018 to almost 400, including 1,227 individual buildings. There were loud protests from the newly eligible school districts. Note that currently, the money for the vouchers comes from the local district's resources.

The legislature responded to the pending changes by kicking the can down the road—moving the application date for parents from February 1 to April 1, in hopes that given more time they could come up with a workable solution. The House acted quickly and amended a Senate bill, SB 89, by a vote of 88-7

to end the EdChoice program and replace it with Buckeye Opportunity Scholarships. The new vouchers would be funded entirely by the state and would make low-income students a priority. The Senate, however, has a different plan. The Senate amended a House bill, HB 9, that essentially preserves the EdChoice program but limits the number of eligible districts to 425.

The latest development is the call by the House Speaker for a conference committee to meet very soon and for the Senate to concur with the House-amended SB 89. At this time the two bodies appear to be at odds in scheduling action. Advocates for public education are supporting this bill primarily because it transfers the cost of vouchers from the local districts to the state and limits the eligibility to families with incomes up to 250% of poverty. There are a couple of other desirable features to the House amendment of SB 89—one is ending academic distress commissions and the other is creating study groups to review testing and its relationship to the state report card and to find better ways to support struggling school districts.

And meanwhile, a group of parents and conservative organizations have

asked the Ohio Supreme Court to block the 60-day delay and let students apply for vouchers based on the earlier expanded list. The suers claim the delay is causing "irreparable harm to Ohio's children and families."

AAUW's position on school vouchers is clear: AAUW strongly supports providing an excellent education for all children, not private school vouchers for a few.

Please share AAUW's Quick Facts on Private School Vouchers with your branch members and friends. Key points are that vouchers weaken public education, and vouchers do not improve academic achievement. The document cites two studies in Ohio (among others) that found that vouchers do not result in better outcomes for students; students actually performed worse on standardized tests than their peers who are not in the voucher programs.

Despite AAUW's strong position against vouchers, members may want to contact their representatives to encourage their support of this solution. Adoption of amended SB 89 appears to be the lesser of two evils in that it stops the drain on local school district finances and limits student eligibility to those in most need.
